Property

School districts across the state who are loss free are experiencing a 20-25% increase in premium on average. ROCSD reflects an increase of 21.9% with two (2) claims during the previous policy period.

Workers Compensation

 - o Programming includes guidelines for driver disqualification criteria and running motor vehicle records (MVRs).
 - o Preproduced training materials and on-demand videos help employees learn safety practices, with a goal of reducing auto claims, while freeing up administration to perform other critical functions.

Policy Wide

Since 2012, Red Oak is at an 80% loss ratio. EMC's goal is to have districts loss ratio be less than 50%. If the safety group performs well overall, dividends will be paid out to individual school districts.

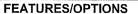

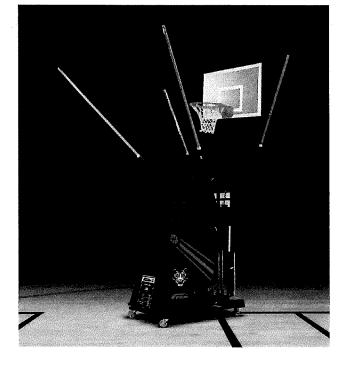

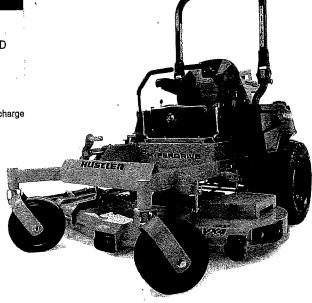
